Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users. This General Public License applies to most of the Free Software Foundation's software and to any other program whose authors commit to using it. (Some other Free Software Foundation software is covered by the GNU Lesser General Public License instead.) You can apply it to your programs, too.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

0. Definitions.

"This License" refers to version 3 of the GNU General Public License.

A separable portion of the object code, whose source code is excluded from the Corresponding Source as a System Library, need not be included in conveying the object code work.

A "User Product" is either (1) a "consumer product", which means any tangible personal property which is normally used for personal, family, or household purposes, or (2) anything designed or sold for incorporation into a dwelling. Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give

一般利用者向け IPA フォント使用許諾契約書（エンド・ユーザ・ライセンス）

独立行政法人情報処理推進機構（以下、「IPA」といいます。）は、「IPA フォント」と題する

デジタル・フォント・プログラム（以下、「許諾プログラム」といいます。）を提供するにあたり、この使用許諾契約（以下「本契約」といいます。）に同意いただくことを条件とします。

許諾プログラムの提供を受けた者（IPA からの一次配布・他の利用者からの再配布を問わず、以下、「受領者」といいます。）が、受領した許諾プログラムをコンピュータ（1条に定義するところによります。）にインストールした場合、本契約の内容に同意したものと見なします。

第1条 用語の定義

本契約において、次の各号に掲げる用語は、当該各号に定めるところによります。

1. 「派生プログラム」とは、許諾プログラムの一部または全部に、変更、デザインの加工その他の加除修正等を施したもの、フォント名などのフォント情報や組版に関する情報を含む一連のテーブルなどを変えたもの、またはフォントのアウトラインデータやビットマップデータの一部または全部を追加、修正、削除したものなどをいいます。
